Ordering stickers – England

Two options are available to local authorities to obtain stickers.

- 1) Order **free** 'standard' window or wall sticker versions with the FSA logo and the words 'this scheme is operated in partnership with your local authority' on the front.
- 2) Arrange for the printing of co-branded stickers with the FSA logo and the local authority logo on the front

1) 'Standard' Window and Wall stickers

These are available free of charge through Food Standards Agency Publications and are all printer friendly, **apart from 0 rated window stickers (FSA 1573/0710) which are still in the old format**. Local authorities can order supplies from EC Group on 0845 606 0667 or <u>foodstandards@ecgroup.co.uk</u>. Please quote the order numbers below. The maximum order quantity is 250 for each rating, but if a larger quantity is required please state the reason when ordering.

<u>Wall stickers</u> are intended for use only when no window, door or other transparent surface is available. The information written on the reverse of the regular sticker should be included on the peel off part of these stickers, to be retained by the business.

2) Printing co-branded stickers

The print specification for co-branded versions is detailed below.

- Digitally printed full colour face vinyl, with digitally printed matt white opaque laminated backing
- Supplied on 138gs, release paper, die cut to shape with rounded corners.

- The sizes are as follows:
 - 195mm x 135mm (0-5)
 - 195mm x 100mm (Awaiting inspection)

Use of FHRS imagery
